CALCULATION OF AVERAGE WEEKLY WAGE*

Continuous employment: Include wages earned for same employer over 26 weeks preceding injury; include overtime hours at the straight time rate. Weeks with abnormally low earnings should be excluded.

Week Expressed as Decimal	
1 day =	.143 x weekly rate
2 days =	.286 x weekly rate
3 days =	.429 x weekly rate
4 days =	.571 x weekly rate
5 days =	.714 x weekly rate
6 days =	.857 x weekly rate

When calculating PPD rate, if employee averaged less than 40 hrs/ week recalculate AWW based on 40 hours.

Seasonal employment: One fiftieth of total of all wages earned over year preceding accident.
